II) DETAILED COMPREHENSION

A) 6 points (6 × 1) : 1 ou 0 (tout ou rien).

- 1- Right – Line 4 “out of fear^{et/ou} that he might catch our eye and turn his poisonous attention to us”. l. 17-19 “when they saw ... computer screens”
- 2- Wrong – line 13 “around(eight-thirty)”
- 3- Right – line 15 “There was a delay in the subway.”
Or line 15 “Someone jumped under a train.”
- 4- Wrong – line 18-19 “They immediately refocused their eyes on their computer screens.”/l. 23 “all around me ... terminals”/l. 30 “watching the seconds tick de
- 5- Wrong – line 23 “You were six minutes late.”
- 6- Right – line 33 “conscious of the weekly quota”/l. 26 “to push the product”

B) 6 points (6 × 1)

- 1- line 10 “Eight-thirty,” I said quietly.”/l. 22 “I was just ... things up”/l. 25 “It was a jet
- 2- line 17 – 18 “When they saw Rubinek’s face go crimson.”
Or “(a sure sign he was about to declare war)”/l. 8 “I WILL REPEAT ... AGAIN”
- 3- line 23 – 24 “you were insubordinate.”
- 4- line 29 “You don’t like it, there’s the door.”
And line 36 “or you’re out of here.”
- 5- line 38 “I do know it.” + accepter toute la ligne
